We are the regulator for the optical professions in the UK. Our purpose is to protect the public by promoting high standards of education, performance and conduct amongst opticians. We currently register around 30,000 optometrists, dispensing opticians, student opticians and optical businesses.

We currently have a number of opportunities for legally qualified individuals from a range of backgrounds to play a key part in the regulation of optical professionals by becoming a Legal Adviser to the committees that decide on complaints against registrants and optical businesses.

We are looking for individuals who can offer their skills and knowledge for several days throughout the year to support our fitness to practise function. We particularly welcome applications from applicants who can reflect the diverse mix of our registrants and patients.

Role summary

Legal Advisers are to be appointed for the purpose of giving advice to the Fitness to Practise and Registration Appeals Committees on questions of law arising in connection with any matter which the Committee is considering. They will provide legal advice to the Committee and assist the Chair in making sure that the hearing is conducted fairly. The Legal Adviser drafts the decision of the Committee but does not play any role in the Committee decision-making.

Legal Advisers **must have** at least **five years' experience of practice** and must not be a member of the Council. They are to be appointed for the purpose of giving advice to the Fitness to Practise and Registration Appeals Committees on questions of law arising in connection with any matter which the Committee is considering. They will provide timely and appropriate legal advice to ensure a transparent and lawful fitness to practise function, ensuring cases are dealt with efficiently, objectively, and fairly. They will be able to produce high quality draft determinations, ensuring the draft is clear and reflects the background of the case as well as the Committee's findings accurately with any edits actioned in a prompt manner following direction from the Committee.
