INTERIM ORDER APPLICATION DETERMINATION SUMMARY 20 OCTOBER 2023

PRIVATE HEARING

Name of Registrant: Shahid Nazir Registration number: 01-20683 Professional status: Optometrist

Type and length of interim order: The Fitness to Practise Committee determined to make an interim order of conditional registration from 20 October 2023 for a period of 18 months.

The order will be further reviewed within 6 months from today unless all matters are resolved within that time, or earlier should new evidence be made available, or if the registrant, at any time after three months from today's date, requests an early review.

LIST OF CONDITIONS

A1.1 Informing others	You must inform the following parties that your registration is subject to conditions. You should do this within two weeks of the date this order takes effect.
	 Any organisation or person employing or contracting with you to provide paid or unpaid optical services, whether or not in the UK (to include any locum agency).
	b. Any prospective employer or contractor where you have applied to provide optical services, whether or not in the UK.
	c. Chairman of the Local Optometric Committee for the area where you provide optometric services.
	d. The NHS body in whose ophthalmic performer or contractor list you are included or are seeking inclusion.



A1.2	You must inform the GOC if:
Employment and work	 You accept any paid or unpaid employment or contract, whether or not in the UK, to provide optical services.
	b. You apply for any paid or unpaid employment or contract to provide optical services outside the UK.
	c. You cease working.
	This information must include the contact details of your prospective employer/ contractor and (if the role includes providing NHS ophthalmic services) the relevant NHS body.
A1.3	You must:
Supervision of Conditions	 a. Identify a workplace supervisor who would be prepared to monitor your compliance with these conditions (A2 numbers 1-4).
	b. Ask the GOC to approve your workplace supervisor within 2 weeks of the date this order takes effect. If you are not employed, you must ask us to approve your workplace supervisor before you start work.
	c. Identify another supervisor if the GOC does not agree to your being monitored by the proposed supervisor.
	 Place yourself under the supervision of the supervisor and remain under their supervision for the duration of these conditions.
	e. Inform the GOC of any proposed change to your supervisor and again place yourself under the supervision of someone who has been agreed by the GOC.
A1.4	You must inform the GOC within 14 days if you become aware
Other proceedings	of any criminal investigation or formal disciplinary investigation against you.
A1.5 Registration requirements	You must continue to comply with all legal and professional requirements of registration with the GOC.
	A review hearing will be arranged at the earliest opportunity if you fail to:-
	a. Fulfil all CET requirements; or
	b. Renew your registration annually.

Restrictions on practice

- 1. Twice a week on two separate days when you are conducting sight tests on members of the public, your workplace supervisor must directly supervise your sight tests for a minimum of 3 patients per day and review your record cards for these patients.
- You must meet with your supervisor at least once a week to discuss the 6 sight tests they have directly supervised. You must explain to your workplace supervisor which tests you performed, the techniques you used to conduct the tests, and how you arrived at the final information recorded on the patients' record cards.
- 3. At least every 3 months, before the next review hearing or upon request by the GOC, you must submit a written report from your workplace supervisor to the GOC, providing a log of the sight tests they have observed, a record of the discussions at the weekly supervision meeting, their view on the quality of the patient records discussed, and detailing how you have complied with the conditions they are monitoring.
- 4. With your workplace supervisor you must formulate a personal development plan which should be specifically designed to address:
 - upholding professional standards, especially maintaining accurate patient record
 - keeping clinical knowledge and skills up to date, especially concerning conducting appropriate tests and recording accurate results
- 5. Submit a copy of your personal development plan to the GOC for approval within 4 weeks of these conditions taking effect.
